- A degree from a recognized university
- Kenya Certificate of Secondary Education KCSE mean grade C+, with a C in both Mathematics & English
- IGCSE-A LEVEL who attain A-C with at least two principle passes.

ACCA DIPLOMA OPTION

Those who obtain grade C- in KCSE or IGCSE-O LEVEL certificate or IGCSE –A LEVEL and do not attain A-C with at least two principle passes are eligible to enroll for ACCA diploma. Upon completion of the ACCA diploma, a candidate will be eligible to enroll for the ACCA associateship program as well as a USIU-Africa degree program.

All CSoB programs have been accredited by ACCA and therefore USIU-Africa students receive exemptions once they enroll depending on the program applied for.
